INTERNATIONAL BUSINESS MINOR

Undergraduate Fact Sheet

Because of an increasing focus on international issues and global business, many students are becoming interested in international business. As a result, the School of Business at West Chester University offers a minor in International Business within the Department of Management. The International Business minor is multi-disciplinary, combining coursework in International Business, Foreign Language, and other related disciplines, such as Anthropology, Economics, Geography, History, and Political Science. A minor in International Business is an important academic degree since the world has "shrunk" and global commerce has increased dramatically over the latter part of the 20th century and into the 21st century. In addition, the minor in International Business should be a positive step in preparing graduates for international careers.
