AGENDA ITEM III – PUBLIC COMMENT: LIMIT OF TEN (10) MINUTES:

Chairperson Tomlinson asked if there was any public comment. Being none, Dr. Margaret Ervin, President of the WCU Chapter of APSCUF was invited to present greetings. Dr. Ervin reported that the chapter is celebrating the bargaining agreement with much appreciation for the attention to the many details. She also expressed appreciation for Dr. Fiorentino's support for her colleagues. West Chester

has a "strong productive partnership" including working together on the Governor's Blueprint for Higher Education in ways that will enable the university to continue to contribute to student success. The Blueprint calls or a 15% increase in funding for the proposed system, which would incorporate four-year institutions with community colleges under a single umbrella. Dr. Ervin expressed concern that Pennsylvania will follow the model of states like West Virginia which is overly focused on workforce development at the expense of a general education.

President Fiorentino expressed that he was pleased that the governor is talking about significantly increasing funding for higher education. Much work is yet to be done but he is encouraged that people are listening and thinking about a path forward.
