**Laptop:** We will often explore computer generated visualizations to help conceptualize objects in Euclidean and non-Euclidean geometries. It is recommended that you bring a laptop to class with wireless internet access (to use [Desmos](#)) and access to Mathematica or Maple. It is not expected that you have any experience using these tools and you will usually only be asked to apply code written for you. However, it will be difficult to avoid them so I encourage you to be open to using them. **Prerequisites:** There are no official prerequisites although undergraduate content will be assumed, particularly, linear algebra, Euclidean geometry, and group theory.

**Course Outline:** This course is a rigorous introduction to geometry from a transformational point of view. Emphasis will be on conics, affine geometry and projective geometry. Hyperbolic geometry, inversive geometry and spherical geometry are taught in the sequel MAT 533, Geometry II.

1. Conics: Conic Sections and Conics; Properties of Conics; Recognizing Conics; Quadratic Surfaces (if times allows)
2. Affine Geometry: Geometry and Transformations; Affine Transformations and Parallel Projections; Properties of Affine Transformations; Using the Fundamental Theorem of Affine Geometry; Affine Transformations and Conics.

3. Projective Geometry: Lines. Perspective; the Projective Plane  $\mathbb{RP}^2$ ; Projective Transformations; Using the Fundamental Theorem of Projective Transformations; Cross-ratio.
4. Projective Geometry: Conics. Projective Conics; Tangents; Some Theorems on Projective Conics; Duality and Projective Conics.

**Course Student Learning Outcomes (CSLO):** Upon completion of this course, students will:

1. contrast properties of Euclidean, affine, and projective geometries,
2. construct proofs of geometric results,
3. illustrate the role of geometry in problem solving,
4. investigate the mathematical applications of geometry,
5. explain geometric concepts orally and in writing.

**Evaluation:** Student learning outcomes will be assessed through 6 graded homework assignments and 3 exams (see the table below). Your grade will be determined (**as a weighted average**) by your performance on these assessments.

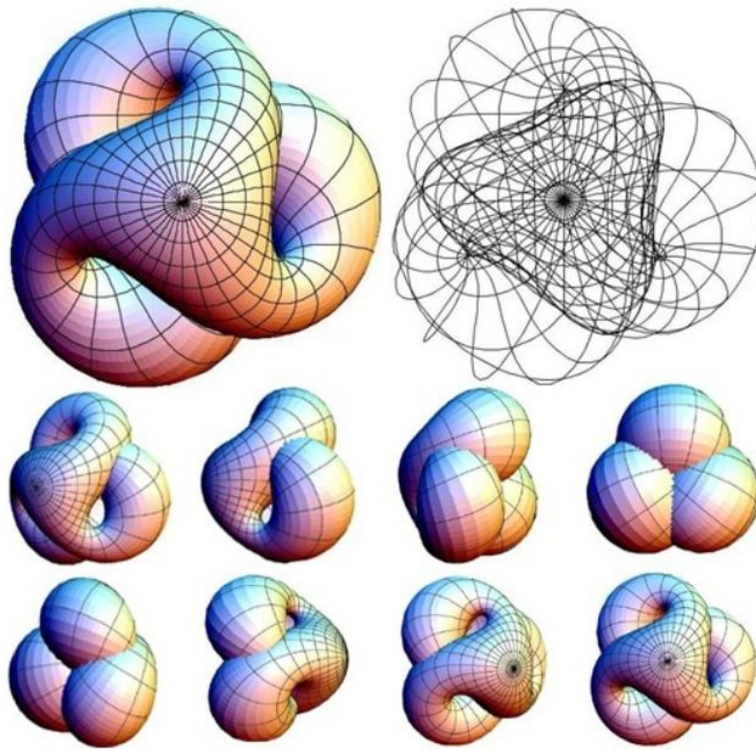

**Written Homework Assignments:** It can be difficult to feel comfortable with an area of mathematics without exploring a variety of examples. To this end, homework will be assigned regularly and scored out of 100 points. Typically, the option to complete some corrections to certain homework problems may be possible upon request. Homework corrections must be turned in with a brief reflection describing what went wrong the first time and what you learned from doing it again.

**Class cancellation policy:** If a class must be canceled, you will be informed at a prior class meeting.

**Make-up Policy:** Make-up exams will be granted only for excused absences accompanied with documentation, e.g. a doctor's note, police report, etc. In order to be approved for a make-up quiz or exam, you must notify me prior to the start of that assessment. 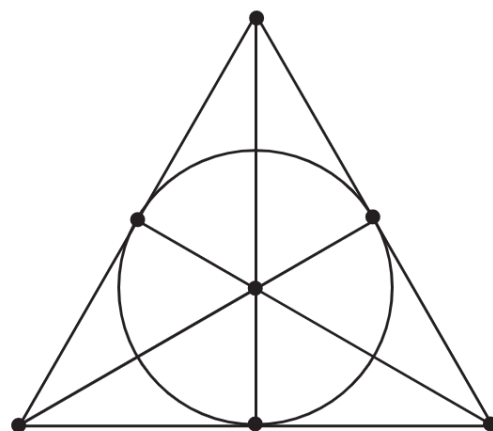
